Q (a) The details of the refining capacity of each oil refinery in the country;

Ans. (a) At present total 23 number of oil-refineries are functioning in the country. The refinery-wise current installed capacities are given below;

Q (b) whether the current refining capacity is adequate to meet our oil demand, and if not, whether Government plan to set up more refineries;

Ans.(b) Currently, the country is self-sufficient in Refining and exports Quality Petroleum Products. However, some of the products like LPG is in short supply and is imported.

MoP&NG has prepared projection for requirement of future refinery capacity in India upto 2040. The Refining Sector is deregulated and as per the expansion plans indicated by the Refining Industry upto 2030, the capacity will be adequate to meet the demand.

Q (c) if so, the details thereof;

Ans.(c) Besides expansion of existing refineries, Green field Refinery of 9 MMTPA capacity is coming up at Barmer, Rajasthan. Further, 60 MMTPA Refinery is planned at Ratnagiri, Maharashtra.

Q (d) whether Government is considering investing money to raise oil refining capacity in Maharashtra and other places of the country and if so, the details thereof; and

Ans.(d) Inputs received from Indian Oil Corporation (IOC) is furnished below :

Yes, the Government is considering investing money to raise oil refining capacity in Maharashtra.

In this context, a Joint Venture Company, Ratnagiri Refinery & Petrochemicals Limited (RRPCL) has been formed amongst Indian Oil Corporation Limited, Bharat Petroleum Corporation Limited, Hindustan Petroleum Corporation Limited. Saudi Aramco and ADNOC have expressed interest to participate in this mega project with 50% equity stake. The JV plans to create 60 MMTPA Refinery cum Petrochemical complex, which shall be the largest of its kind in the world.

The Configuration Study for the 60 MMTPA Refinery cum Petrochemical complex in progress and is expected to be completed by March, 2019.

Q (e) whether Government has sought or plans to seek help from any foreign Government or company to meet the oil demand in the future and if so, the details thereof?

Ans.(e) Already covered in reply to Q (d) above. MoP&NG may reply suitably.
