Q (a) The total refining capacity of private sector refineries, in the country, company-wise;

Ans. (a) At present total 3 number of private sector refineries are functioning in the country. The refinery-wise current installed capacities are given below;

Private Sector Refineries

1.	DTA-Jamnagar - 1999	Reliance Industries Ltd.	33.000

In addition to above, two refineries viz. BORL-Bina (Joint Venture of BPCL and Oman Oil Company) of Capacity 6.0 (expanded to 7.8 MMTPA) and HMEL-Bhatinda (Joint Venture of HPCL and Mittal Energy Investment Pte Ltd, Singapore) of capacity 11.3 MMTPA are under Joint Venture.

Q (b) The consumption of petroleum products in the country;


Ans.(b) The total consumption of petroleum products during last three years are as under :

(Figs. in 'Million Metric Tonnes per Annum)

Year	2015-16	2016-17	2017-18
Petroleum Products Consumption	184.674	194.597	204.922

Q (c) whether the oil refining capacity has increased during last three years and if so, the details thereof;

Ans.(c) Yes, the Oil refining capacity has increased from 215.1 MMTPA (as on 1.4.2015) to 247.6 MMTPA (as on 1.4.2018).



Q (d) whether permission for export of petroleum products has been granted to public and private sector oil refineries operating in the country and if so the details thereof; and

Ans.(d) Yes. India is presently net exporter of Petroleum Products. The refineries trade products internationally as per domestic demand and market dynamics. RIL SEZ Refinery has been set up as export oriented unit.

Q (e) whether profits of oil refineries have increased during the last three years and if so, the details thereof; and

Ans.(e) Oil Companies may reply.

Q (f) The steps taken by the Government to increase oil refining capacity of public and private sector oil refineries to fulfill rising demand of petroleum products in the country ?

Ans.(f) The Refining Sector is deregulated. In order to assess requirement of future refinery capacity in India, MoP&NG had set up a working Group to prepare projection for requirement of refinery capacity upto 2040. As per the report of working group and expansion plans indicated by the Refining Industry upto 2030, the capacity will be adequate to meet the demand.
