- Q (a) whether the Ministry has issued an order to implement BS-VI standards from 1 April 2020, if so, the justification for leapfrog from BS-IV to BS-VI skipping BS-V standards
- Ans (a) The Expert Committee on Auto Fuel Vision and Policy, 2025 in its report dated May, 2014 mentioned that BS-V fuel quality and emission norms are proposed to be implemented in the entire country from 01.04.2020 and conceptually the BS-VI emission regime can become applicable with effect from 01.04.2024 for all classes of vehicles. The matter of introduction of BS-V and BS-VI grade Auto Fuel in the country was discussed in May, 2015 in consultation with OMCs and other stakeholders and it was observed that there is no major change in fuel quality between BS-V and BS-VI fuels. Accordingly, Govt. in its inter-ministerial consultation meeting held on 6th January, 2016 decided instead of step-wise switching over from BS-IV to BS-V and then from BS-V to BS-VI, the country will leapfrog directly from BS-IV to BS-VI Fuel Standard and BS-VI will be implemented in the country w.e,f 1.4.2020. MoRTH vide Gazette notification dated 16.9.2016 has issued an order to implement BS-VI standards from 1 April 2020.
- Q (b) whether the auto sector is ready for this leapfrog, if not the reasons for the same and what incentives the Ministry is giving to auto sector for this transformation?

Subject: Introduction of BS-VI Auto Fuel in the country w.e.f. 01.04.2020-Reg.

Sir/Madam,

I am directed to refer to the subject mentioned above and to say that Expert Committee on Auto Fuel Vision and Policy, 2025 in its report has mentioned that BS-V fuel quality and emission norms are proposed to be implemented in the entire country from 01.04.2020 and conceptually the BS-Vi emission regime can become applicable with effect from 01.04.2024 for all classes of vehicles. This will give a gap of four years to the automobile manufacture for upgrading and adjusting their technology, design and standards.

2. The matter of introduction of BS-V and BS-VI grade Auto Fuel in the country has been discussed in consultation with Oil Marketing Companies (OMCs) and other stake-holders and it has been observed that there is no major change expected in the fuel quality between BS-V and BS-VI fuels. As such, this Ministry is of the view that instead of step-wise switching over from BS-IV to BS-V and then BS-V to BS-VI, there should be direct switch-over to BS-VI from BS-IV w.e.f. 01.04.2020. Accordingly, it is conveyed that this Ministry is ready for switching-over directly from BS-IV to BS-VI quality w.e.f. 01.04.2020.
